Autumn News & Notes

With cooler weather here and winter's arrival just around the corner, keep these important items in mind:

CURBSIDE BRUSH PICKUP is throughout the year on or about the 3rd Thursday of the month. If you have brush that has not been picked up please contact the Village office. Leaves will be picked up on Thursday's for the month of October when possible. Leaves must be bagged and at the curb by 8 am. Please note leaf piles may not be left in the street. Leaves may be left in the bulk piles next to the recycling bins in the Village parking area east of Lincoln Avenue. Please observe the directions posted at this site: Put leaves and brush in separate piles. Empty bags of leaves onto the leave pile.

Snow Removal Reminders

Please keep your side-walks clear of snow and ice to provide safe passage for everyone!

The Village Board would like to remind residents and business owners that snow and ice MUST be removed from all side-walks. According to Village Ordinance 6-2-8 property owners have 24 hours from the time snow ceases to accumulate to remove snow and ice from sidewalks that adjoin their property. Snow cleared from side-walks, driveways and parking lots cannot be shoveled, blown or plowed into the highway, street or any public right-of-way, where it poses a safety hazard to road pedestrians and crews. motorists.

If you do not remove snow in a timely manner, the village will do it for you and bill you \$100 per hour, 1 hour

minimum. Any portion beyond a full hour will be charged the full hourly rate. Each 24-hour period will be considered a separate offense and billed according to ordinance.

STREET PARKING The Village Board made changes to allow overnight street parking during with winter months unless it snows. If it snows you may not park on the street during snowfall and 24 hours after snowfall.

PLEASE LEND A HAND — Clear snow from fire hydrants so firefighters have clear access to the hydrants in an emergency.

CAMPFIRES

BURNING REGULATED: Under Village ordinance 5-3-7, BURNING is prohibited, except for......

Enjoy your campfires this fall. For everyone's safety please make sure you are following the regulations. Campfires are allowed during the hours of 12:30 pm and 2:30 am and must be 15 feet from any building or structure and shall be confined and contained within an area protected by a barrier of stones or other noncombustible material. Campfires cannot be left unattended.

BURNING PROHIBITED: This prohibition shall include but not limited to: garbage, brush, leaves, grass clippings and other yard waste, asphalt, rubber, plastics and oily substances.

Dog Registration

Licenses expire Dog December 31 οf each year...Wisconsin Stats. 174.05 requires that all dogs over five (5) months of age be licensed. A current rabies vaccination is required at the time your license is obtained. Vaccination records are only needed if there is an update from last year or if this is a new animal to be licensed.
